Make 2014 Count for Patient Safety

Welcome to 2014 – a huge election year resplendent with opportunities to meet legislative candidates and regulatory board members. This is your year to share your story about what it means to be a physician anesthesiologist and form working relationships with elected officials that will last for years to come.

Good advocacy begins with good relationships; it is usually easier to talk about serious issues with a friend than with a stranger, and discussing legislative issues is no different. Forming working relationships with lawmakers is as easy as setting up a meeting at their office and offering yourself as a source of information on health care policy.

If your lawmaker is not available for a meeting when you are, try to meet with legislative staff instead. Having good interaction with staff is often the best way to relay your ideas and concerns to a lawmaker. If your work environment allows, invite lawmakers and their staff to spend a day with you; this hands-on experience will stay with them for life and really drive home the importance of patient-centered, physician-led health care.

Even if your state is not in legislative session this year, remember that the state boards of medicine, nursing, insurance, health or other relevant regulatory boards are always meeting and promulgating rules. In fact, we are witnessing more instances of non-physicians promoting their agendas through regulatory boards instead of the more appropriate legislative route. Additionally, in 2013 medical and nursing boards in two states were asked for their opinions on opt outs, so establishing close contacts within the boards is more vital than ever for the promotion of patient safety.

Physician Anesthesiologist Runs for State Senate

Recently, long-time ASA member and past-president of the Oklahoma Society of Anesthesiologists, Ervin Yen, M.D., announced his candidacy for the Republican nomination to represent Oklahoma's District 40 in the Oklahoma State Senate. District 40 covers Oklahoma City and is currently represented by Sen. Cliff Branam (R), who is term-limited from seeking reelection.

Dr. Yen was born in Taipei, Taiwan. His parents were originally from mainland China and were worried about the Communist threat to Taiwan. For the sake of their family, Dr. Yen's parents chose to immigrate to the United States when he was four years old. The Yen family selected Oklahoma City as their home, and Dr. Yen has lived there ever since – now with his wife of 27 years and five children.

After graduating from the University of Oklahoma, Dr. Yen attended the College of Medicine at the University of Oklahoma. He completed his residency in anesthesiology in Oklahoma City, where he has practiced medicine for almost 30 years. His primary hospital of practice for the last 20 years is Integris Baptist Medical Center, where he has focused on cardiac anesthesiology, taking care of patients for vascular surgery, chest surgery and heart surgery, including heart transplants, lung transplants and left ventricular assist devices.

Although the Oklahoma legislature currently has two physicians in the state house, there are no physicians in the Oklahoma State Senate. Dr. Ervin Yen is committed to bringing a physician's voice to the health care discussion in the Oklahoma Senate. Dr. Yen says that he "want[s] to be the go-to guy in the Senate when health care issues appear" and is "more concerned with health care reform as a health care consumer than as a health care provider." In his press release announcing his candidacy, Dr. Yen said that "When I'm elected, I will do everything in my power to enact meaningful health policies that benefit Oklahomans."

Two other physician anesthesiologists are currently serving as state legislators in Tennessee and Texas. ASA Immediate Past President John Zerwas, M.D., is currently serving his fourth term as state representative for the 28th District of Texas. Former president of the Tennessee Society of Anesthesiologists, Steve Dickerson, M.D., was elected to the Tennessee Senate last year and serves Tennessee's 20th District.

One physician anesthesiologist is currently serving in the U.S. House of Representatives, Andy Harris, M.D. Currently in his second term, Dr. Harris represents Maryland's 1st Congressional District. Two ASA members are running to join Dr. Harris

in Congress, Valarie Arkoosh, M.D., is running in Pennsylvania's 13th District and Vanila Singh, M.D., is running in California's 17th District.

More physician anesthesiologists involved in the political process means exponentially more opportunities to advocate for patient safety and improved health care practices. AA Partnership Takes Flight

Since the initial certification of Anesthesiologist Assistants (AAs) in 1992, the pool of certified practitioners has grown to nearly 1600 with authority to practice in 16 states. The Anesthesiologist Assistants Partnership (AAP), formed in February, 2013, acknowledges the progression of the profession but also recognizes the need to progress into the future. This partnership, formed by representatives of the ASA (American Society of Anesthesiologists), AAPD (Association of Anesthesiologist Assistant Program Directors), ARC-AA (Accreditation Review Commission – Anesthesiologist Assistants) AAAA (American Academy of Anesthesiologist Assistants), and the NCCAA (National Commission for the Certification of Anesthesiologist Assistants), was developed to serve as a steering committee to drive growth initiatives in every aspect of the AA profession. Representation by all stakeholder organizations including representation by both physician anesthesiologists and AAs demonstrates the tangible benefits of a truly effective team model to pre-emptively address issues facing the anesthesia workforce with the primary objective being patient safety.

To get the wheels of progress rolling, the AA Partnership has contracted with Professional Examination Services of New York to strategically administer a comprehensive AA practice analysis survey. This analysis will not only serve to specify the tasks requested of AAs in the workforce in various regions and across various practice models, but will also be used as a tool to ensure that AAs are provided with the education to perform the necessary skills to remain competitive in the workforce and to succeed as exemplary care team providers. A special task force composed of experienced physician anesthesiologists, anesthesiologist assistants, and educational program directors from a diverse cross section of providers throughout the

country, have been selected to participate in this valuable initiative. Other key thought leaders and educational stakeholders will be used to conduct interviews and analyze sequential data as needed.

The task force met in August with ProExam's testing experts and psychometricians. The result of this first meeting was the delineation of specific job tasks and core competencies of AAs as well as the identification of target audiences to be addressed. The upcoming survey will focus on practicing AAs, employers of AAs, and prospective employers of AAs. The results of the study will be used not only as a blueprint for future certification examinations but to drive necessary revisions to the minimum standards of AA education, and provide insight on how current employers of AAs utilize practitioners. The AA Partnership also hopes to gain insight on barriers to AA employment.
